TERMS AND CONDITIONS

Please read the Terms & Conditions carefully before filling the tender.

a) Eligibility & Other conditions:

- 1) The Tenderer should be a MNRE registered channel partner.
- 2) MNRE Grading of atleast 2B (registered channel partners with other below 2B to be considered on case to case basis).
- 3) Turnover of project company, or its direct parent company to be atleast 5 crore/year for preceeding 3 financial year and cumulative of 30 crore.
- 4) Technical Experience of the Company to be 600KWP.
- 5) Project Company or parent company to have Net Worth of atleast 10 cr. at the time of bidding.
- 6) Bidder should have business or local representative in Pune/Mumbai city.
- 7) The MTE Society reserves the right, at its discretion, to cancel the tendering process at any point of time, if it does not receive the tender/s matching with its requirements/expectation.
- 8) Authorization letter nominating a responsible person of the tenderer to transact the said tender business with the MTE Society, must be attached along with tender bid.
- 9) Sealed Envelope (Tender bid) of the tenderer will be opened in the presence of Tenderer and opening authority of Society through regular procedure / practice.
- 10) The tenderers bid must remain valid for a period of 60 days after the date of opening of sealed envelope (Technical Bid) with an option in

favour of Society to request the tenderers to extend the bid validity period.

- 11) The MTE Society shall also analyze that there is no collusive or fraudulent practice involved in the entire tendering process amongst all or few of the tenders received and the decision of the society in that behalf will be final and binding on all tenderers.
- 12) **The successful tenderer will have to deposit Rs.Twenty Five Thousand only as interest free security deposit with MTE Society (which will be refunded one month after completion of the project).**
- 13) **Project Agreement after the acceptance of the tender will be subject to the approval of Charity Commissioner, Pune (if necessary)**

b) Technical Specifications:

- 1) Solar Panels to be used should conform to Bloomberg BNEF Tier 1 Manufacturer, top 10 list only. Additional Manufacturers needs pre-approval.
- 2) Inverter : ABB or Delta only.
- 3) Wires : Polycab or KEI or equivalent with UV coating.
- 4) Solar Mounting Structure : to be provided with 15 years rust free warranty and should be able to withstand 150 kw/hr windspeed
- 5) Bidders to provide total service support for duration of agreement and free replacement or service on site.
- 6) Project to be completed from maximum of 4 months from date of award.

- 2) Bidders to bid for a fixed unit tariff rate structure
